- To register, a non-refundable deposit of \$250 must accompany each application. [If applying for Session Five only, a non-refundable deposit of \$150 is required.] (Make check payable to "Clara Barton Center for Children.") This deposit will be applied to summer camp tuition, and is returned only if no space is available.
- Priority for enrollment will be given to children currently enrolled at CBCC only until February 8, 2010.
- Clara Barton Summer Camp reserves the right to cancel any class if enrollment requirements are not met. In this instance, tuition paid will be returned.
- Withdrawals must be submitted in writing by April 16, 2010 in order to receive a refund of tuition paid, less the \$250 non-refundable deposit. There will be no refunds of tuition made after April 16, 2010.
- A bill for summer camp tuition will be mailed on or about March 1, 2010.
- By March 12, 2010, 50% of the total summer camp tuition must be paid or your child's space may be forfeited.
- The balance of summer camp tuition is due on May 14, 2010.
- Campers must enroll for a full session and tuition is not prorated for absence from sessions.
- Campers in the Summer Cardinal (older 4's & 5's) and Eagle (older 4's & 5's) classes must attend 5 days per week.
- Campers in the Summer Toucan (2's), Summer Hummingbird (young 3's), and Summer Puffin (older 3's & young 4's) classes can attend 3, 4 or 5 days per week.
- A child must be at least two years old by May 31, 2010 in order to attend summer camp.
- The majority of our regular classroom teachers take their vacations during the summer months, so your child may not have the teacher who teaches in a particular classroom during the school year as his or her summer camp teacher. Also, your child may not have the same teachers for each session although we strive to maintain teaching team consistency throughout the summer for each class group.
